Fees Schedule

1. IT Consulting/PC Conditioning Services

*****The focus market of services offered is for private computer users and home based businesses. Additional commercial computer/consulting services will be considered upon request*****

- a) \$60 - Install VirtualBox/Linux Mint safe browsing solution installation and training with 30 day telephone support
- b) \$60 Minimum - Basic hardware/software repair/upgrade (customer supplied parts) with parts manufacturers warranty
- c) \$80 (Individual); \$100 (Home Office); \$120 (Commercial/Cloud) Minimum - On-site Service/Training - 1st hour; \$40-\$60 Minimum - Remote Service/Training- 1st 1/2 hour...\$80-\$120 per hour for each additional hour (15 minute increments)
- d) \$100 Minimum - Host operating system restoration (if possible) or clean install and setup with Open Source Office Suite, Virus/Malware protection (Free Version) and 30 day telephone support (\$100 - Reflect Recovery; \$140 - OEM Recovery/Clean Install/Preconditioning)
- e) \$20 Minimum - Each additional service w/base rate:
 - i. Basic hardware repair/upgrade (customer supplied parts) with parts manufacturers warranty (\$20 - \$60)
 - ii. Install Virtual Machine/Guest OS safe browsing solution - installation and training with 30 day telephone support (\$40 - \$60)
 - iii. Install recovery solution, create recovery/data partition and recovery disk with printed instructions and first event telephone support
 - iv. Equipment pickup/delivery/setup including Ethernet connection (per each service date/event)
- f) \$20 - Minimum surcharge for installation and configuration of each additional application/hardware component with 30 day telephone support
- g) \$20 - Minimum surcharge for data recovery (options and estimate provided upon determination of data integrity - data charges usually range between \$20 - \$60)
- h) \$1 per mile surcharge travel time (travel to site - one way)

2. Organizational Development Facilitator

- a) Strategy: Perform workflow and technology assessments
- b) Identify the source of data, the current chain of custody of the information derived from the data, how the information is made useful and available to associates, and how the data and information is stored and protected from loss or corruption
- c) Once the assessment is complete, explore the available technologies and identify any gaps between the tools that are currently in use and those that are available
- d) Perform a "value analysis" that considers the impact "bridging the gap" may have on the workflow and proficiency of the business activities and prioritize any solutions that are deemed valuable enough to adopt
 - i) \$80 per hour assessment/planning/recommendation fee
 - ii) \$120 per hour installation/programming/implementation fee
 - iii) \$80 per hour associate training fee
 - iv) **and/or** 20% Facilitator Fee for all subcontractor service fees
 - v) Upon receipt, by Facilitator, of payment in full, Client shall have full ownership and all rights to the Assessment and Recommendations Summary (if applicable)
